MANAGEMENT FEES

Levies on rights are charged as management fees to cover costs incurred by Sacem during the collection and distribution of author's rights (Article 8 I B 8° of the Statutes). The charge rates shown below are those applicable as of the April 4,

CULTURAL AND SOCIAL ACTION

Cultural action

Sacem's mission, through its cultural action is:

- the career development of songwriters,
- support for publishers,
- promotion of works,
- support for creation and broadcasting projects,
- artistic and cultural education,
- defence of author's rights.

Providence and Solidarity

The purpose of the Sacem Assistance Allowance Plan (RAES) is to allocate, under certain conditions, allowances to members over 63 years of age.

The solidarity funds are used for mutual aid, death allowance and ad hoc help.

FINANCING

There are two financing mechanisms:

- In accordance with Article L 324-17 of the Intellectual Property Code, Sacem is required to use 25% of the sums derived from the remuneration for private copying for the purposes of aid activities for creation, broadcasting of live performance, and the development of artistic and cultural education, as well as for artist training activities.
- In accordance with the Statutes of Sacem (Article 4-2 and 4-3 and Article 33), levies are made under the cultural action plan to enhance the social repertoire and ensure its promotion to the public, and under the provident, solidarity and mutual assistance plan to establish and ensure the payment of benefits with regards to social welfare. These levies, which are charged on the net distribution rights of management fees, shall amount to 10% of the public performance rights (1% for online operations and abroad operations) and 3% of the mechanical reproduction rights (1% for online operations and abroad operations and 5% for private copying rights), excluding specific provisions determined by the Board of Directors on certain types of exploitation.
