If you have composed or are the publisher of a musical work that has been used in a film or a series episode, here's what you need to do to ensure that your royalties are distributed correctly.

Please wait until you have the final cut of the music used in the film or TV series episode. Based on the cue sheet provided by the producer or editor, etc., you will then be able to:

- Register your original works online
- Fill in the cue sheet listing all the music used in the film or TV series episode

NB: We recommend you use Sacem's cue sheet template as it contains all the information required for us to process the registration. We do accept other formats, but they must include all the mandatory fields we require.

• Send us the completed cue sheet

## 1. Register your original works online

Sacem considers "original film music" to be any musical composition created specifically for a fiction film, documentary or TV series. The work can be instrumental music, as well as a song.

You must **register individually all of your original works** that feature in the film or TV series episode.

You can register a work via your online member account by heading to the section "Register a work online." For the "Genre of work", please select "Musique de film (Music for Film)" from the dropdown list.

When registering original film music, don't forget to upload the audio file. We need this in order to validate your registration.

Incomplete registrations submitted will result in a delay in processing time.

## Tips:

Please note: when filling in the cue sheet listing all the original film music featured in the film or series episode, please enter the song titles exactly under the names in which the works have been registered (see point 2 below).

It is really important that you use titles that are comprehensible and make the work easily identifiable (do not give works titles such as "theme tune").

Original film music which features vocals that are sung must be registered according to genre, as this makes it easier to identify the work when used in other contexts.

For published works, registrations must preferably be made online, otherwise they can be done manually on paper and sent to us by post. Publishers can also register works via CWR (please contact us at <u>oeuvres.editees@sacem.fr</u> for more information).

The online registration service is not yet available for public domain works created specifically for a film.

## 2. Fill in the cue sheet listing all the music used in the film or TV series episode

If possible, please wait until your works appear as registered in your member account before filling in the cue sheet. Once your works are registered, they will be attributed identification codes (an ISWC and Sacem Work Code) which you'll need to include in the cue sheet. These codes help make the registration and identification process must faster for Sacem.

Please fill in Sacem's cue sheet template available from our website. The cue sheet looks like an Excel form which you can <u>download and fill in</u>. It contains all the essential information which enables Sacem to clearly identify the works (both original and pre-existing) used in the film or TV series episode.
